Mr. Deppe stated, "So as Commissioners, I think it's important that we hear the positive as well as the negative. This led me to the reports that our new RV Camping area, when it opened...there was some negative activity. I was just wondering if there is something that we can address so we can improve the negative comments that we have been given."

President Swanson stated, "Mr. Craver is here and I think those are in the lines of a shake down reviews. I think overall, Mr. Craver can tell you the response has been overwhelmingly positive. All the spaces have been used. We are very grateful for the foresight of this Commission in making those spaces possible because they create revenues that will be used to further the mission. Is there something specific that you want to address?"

Mr. Deppe stated, "It just stated in his report that he had some negative feedback."

President Swanson stated, "I think that because it is brand new, there is not a lot of shade because we haven't had time to plant trees and we are still trying to get the seeding. Mr. Craver, do you have anything you want to mention about the new RV Site? And if you could, could you move to the microphone...I am sorry that is on Mr. Reagan's desk so that the people at home can hear you as well."

Mr. Craver stated, "Uh, the press release went out the Monday before Labor Day weekend. We filled it up and it's been full ever since. Uh, yes, some folks are a little concerned about the lack of trees in the area. Uh, Mr. Mills is addressing that. We are looking to donations, hopefully, we will do our best to do what we can do. It is new construction and Mr. Mills and I both would have liked to have seen lush green grass there, and that area was hydro-seeded by a contractor the first part of June. Uh, and some of it came in and some of it didn't. Obviously, when you open up something new, you want it to be perfect, but due to the demand that we saw throughout the summer and the conditions, we felt that folks would still be able to enjoy that space and they have each and every weekend since it's been open. Um, reservations are still continuing to come in. Any new campers that know it's our park, their response has been outstanding. So, in terms of the negative comments, uh, I am not sure what you are referencing in the report, there...but does that cover it?"

Mr. Deppe answered, "Yes...yes. If there is something we can improve, it's a beautiful area."

President Swanson stated, "Thank you, Mr. Deppe. Mr. Morthland, please. Oh, I am sorry...Mr. Reagan, please."

Commissioner Reagan was recognized.

Mr. Reagan stated, "Yeah, I just want to say I actually spent the night out there...we camped there Saturday night. The campground is fantastic and all the campers that I talked to were very happy. We were very impressed...so, good job!!"

President Swanson stated, "Thank you for patronizing these wonderful preserves. Comments here or at home? Mr. Langdon, please."

Commissioner Langdon was recognized.

Mr. Langdon stated, "I was out at Illiniwek Park and it was pretty well full. But I noticed that the roads out there are pretty bad. Pot holes and so, are they going to get around to fixing those pot holes or...?"

President Swanson stated, "Right. Mr. Peterson... Thank you, Mr. Langdon. Mr. Craver if you want to weigh in? Mr. Peterson is looking at some funding opportunities to help with some of the infrastructure out there and that is in the pipeline isn't it, Mr. Craver? That's an affirmative, so yes, it is. Thank you. And thank you, Mr. Langdon for using the park."

Mr. Langdon stated, "Everything else was clean and the grass was well-maintained. The restrooms were clean too. Everyone is doing a great job out there."

President Swanson asked, "Are there any other things or comments because we are going to get into the reports in a moment. Ms. Ewert has joined us this evening, is there anything that you would like to lift up? I see a negative. Thank you very much. Ms. Palmer is also joining us this evening, is there anything you would like to lift up from your report to Commissioners?"

Ms. Palmer stated, "No, thank you."

President Swanson asked, "I don't know if there are any other Department Heads or Directors online, if there are...you are welcome to lift up your reports at this time."

12. Commissioner Deppe moved to approve all Routine Reports from the Director and Departments Heads of the Forest Preserve Commission, as presented. Commissioners Adams and Sowards seconded.
